## Transport from the airport to hotels:

A taxi from the airport to the hotels takes about 25 minutes, and costs appr. 300-350 NOK. The airport bus that leaves every 15 minutes or so from the airport, some 20 meters to the right when you come out of the airport building. The bus ride to downtown Bergen takes about 35 minutes and costs 95 NOK.

## Transport from the airport directly to NHH:

If you arrive on Thursday right before the conference, the most convenient would be to take a taxi from the airport to NHH. It takes appr. 25-30 minutes, and costs appr. 400 NOK.

## Transport from downtown Bergen to NHH

There will be bus transport from downtown Bergen (Bryggen area) to NHH on Friday morning. It takes about ten minutes.

## Transport from NHH to the airport:

There will be a bus transport from NHH to the airport on Friday 17 November after the end of the conference.
